Gentlemen.

As you may know I am a local volunteer on the Polperro to Portwrinkle section of the path for the South West Coast Path Association which exists to promote the use of and safeguard the viability of the path.

As such, I have, with the South Cornwall Coast volunteer and the Association's professional Trails Officer been investigating complaints of poor, misleading or missing signs throughout Looe. We have put up some temporary directional signs where possible and particularly on the section from Fore Street East Looe to the steps down into Millendreath.

The Trails Officer has requested new approved timber signs in on the eastern and western sides of Looe and is in touch with Cormac over this.

We need to improve the signage throughout the town and bearing in mind the Conservation areas we would appreciate discussing these improvements with you and the Town Council. I have had an informal meeting with East Looe Town Trust over the additional problems of vehicles driving along the path from Plaidy Lane to East Cliff which again we would like to see solved.

I would be most grateful if you would consider these issues and perhaps give me some dates when we could all meet up and go through the individual problems and find solutions appropriate to all interested parties.
