A387 STABILISATION SCHEME | September 2025

Station Road East Looe

Following a period of planning and geotechnical investigation, we will begin essential stabilisation work in Station Road, East Looe, in September. To facilitate the project, two-way traffic lights will be in place on the A387.

The traffic lights will be monitored by our teams on site to minimise disruption. Furthermore, given the planned events in September, we have made arrangements to remove the traffic lights where it is safe to do so while we work on the project.

To ensure a safe working environment for our team and to protect the safety of our workforce and road users, we need to implement these traffic management arrangements.

Please be assured that we have developed this programme of work prioritising safety and efficiency while ensuring it is as least disruptive as possible. We are committed to completing this project as quickly as we can, with our teams working extended hours to reduce the timeline.

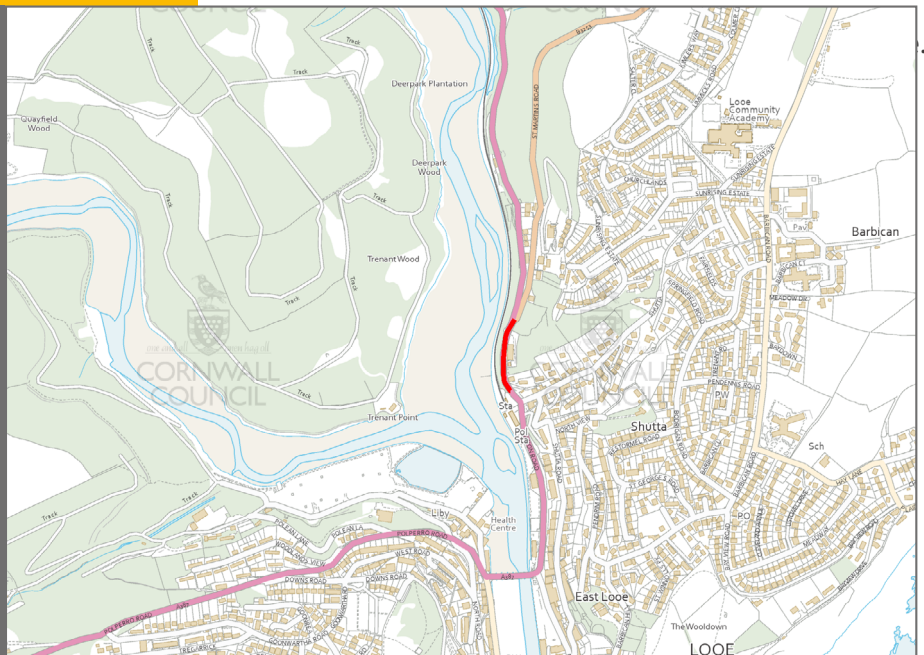

What works are taking place?

Our programme of work will start with the clearance of vegetation along the slope between the road and the railway line. Due to the presence of nesting birds and dormice, the available work window is limited, with a narrow period in September designated for these activities.

Following this, a temporary catch fence will be secured in place to protect the railway area from falling debris. Soil nails and ground anchors will then be installed on the slope face. Lastly, a parapet wall will be constructed to replace the current post and rail fence once the scaffolding has been installed.

It is important to note that the vegetation clearance and the installation of the temporary catch fence will require possession of the railway track. Collaboration with Network Rail is essential for safe access and scheduling of construction activities, due to the proximity to the Liskeard to Looe Branch line.

During construction, a moderate level of noise may be generated. We will use our best efforts to reduce noise levels by implementing mitigating measures wherever possible.

In carrying out this work we aim to ensure the area is stabilised and that the essential highway infrastructure remains secure.

Traffic management arrangements

To minimise the disruption to the local community, traffic management will be in place overnight as follows:

13 September	Traffic lights from 9:00 pm to 7:30 am.
15 - 18 September	
25 - 26 September	
28 September - 2 October	
5 - 9 October	

This means there will be no traffic management in place on the Saturday night of the Kernowfornia event and for the duration of the Looe Weekender.

From 10 October, traffic management will remain in effect until the project is completed.

Please note that the traffic lights on Sandplace Road will remain operational 24 hours a day, 7 days a week.

Our work sites can be dangerous places. Please do not enter the working areas. This is restricted to authorised personnel only.
