

At our August meeting the Planning Committee received an informative presentation from members of the 'Stop Bocaddon Solar Farm' located in Lanreath. The proposal is currently at the Pre-App advice stage which will offer advice to the applicant on their proposal by a CC Planning Officer in the form of application check list which identifies planning constraints and policy contexts which need to be taken into account.

Due to the very close proximity to West Looe a request was made by the Planning Committee which was convened by the Clerk to the Cornwall Council Portfolio Holder for Tourism, Localism and Planning Cllr Sarah Preece that Looe Town Council wished to be made a consultee during the the planning process should the proposal reach a live planning application due to the implications such a proposal could have on Looe . Unfortunately, Cllr Sarah Preece informed Looe Town Council that this would not be possible due to the proposal not being close enough to our parish boundary, however, Looe Town Council is still within its rights to submit comments on the Cornwall Council Planning Portal under the members of the public section.

## **Enforcement Policy**

As Chair I have requested that a policy is drafted in relation to how Enforcement cases are handled/processed by Looe Town Council in terms of reporting to the Cornwall Council Enforcement Team to enable a clear and concise process for both Councillors/ Officers to follow. Our Clerk has agreed to put together a draft 'Enforcement Policy' which I believe will be available for scrutiny by Planning Committee members at our October meeting.
